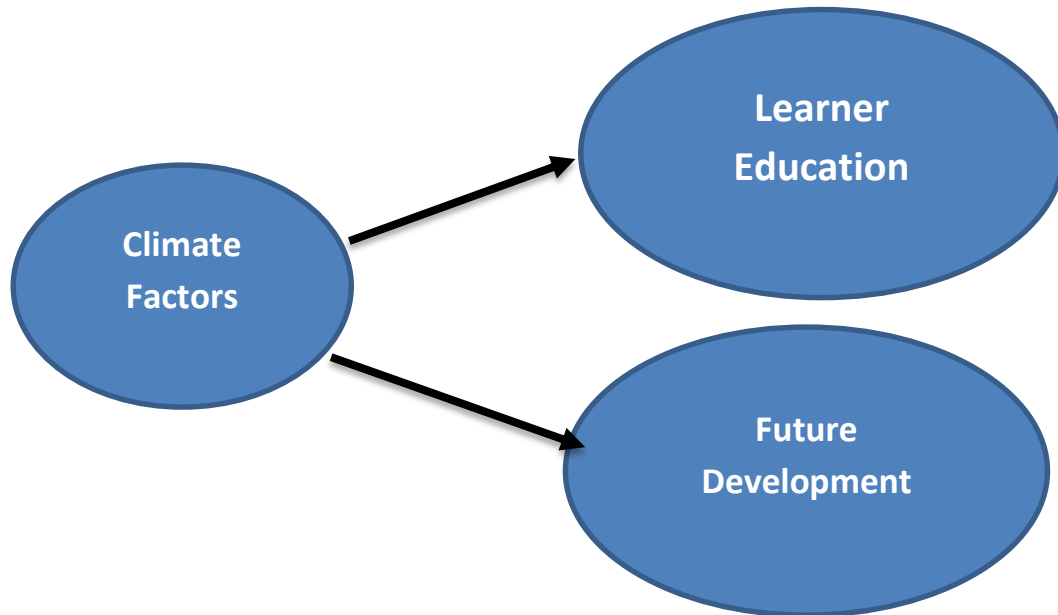


Figure 1. Conceptual Framework

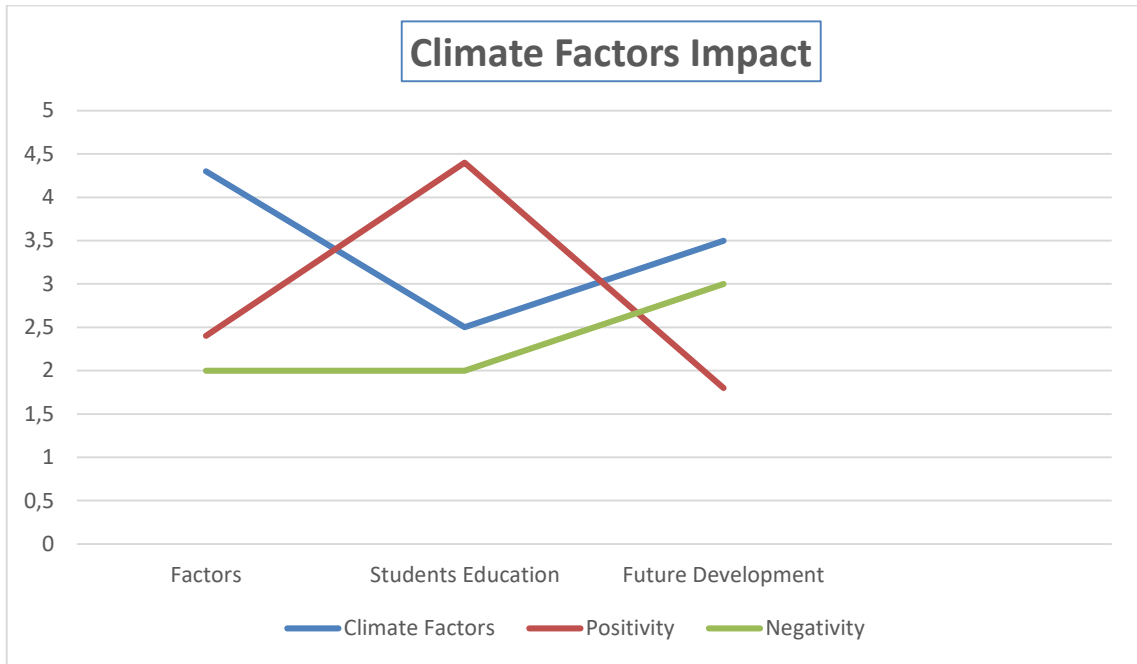


Figure 2. Climate Factors Impact

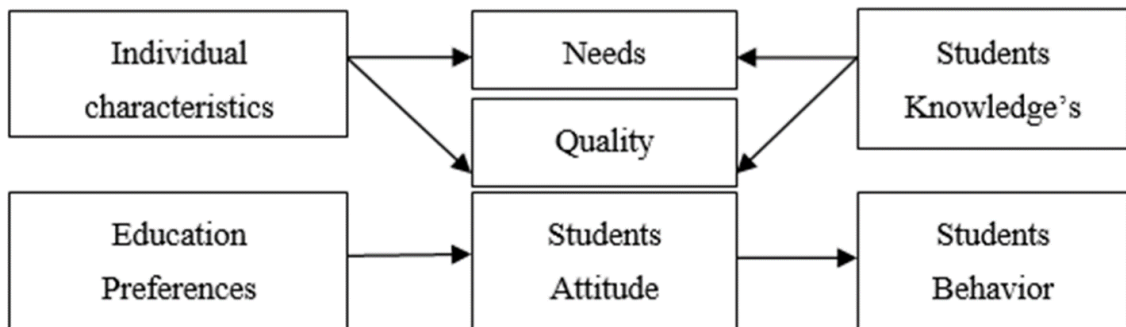


Figure 3. Basis of Individual Needs, Educational Quality Also Student Behavior in Detail
